

The Otoe County Board of Commissioners convened as the Board of Equalization at 8:40 a.m. on Tuesday, October 11, 2016 in the County Courtroom (108) of the Courthouse at Nebraska City; then convened in regular session at 8:45 a.m. Minutes of the previous meetings were not read as each Board Member was furnished with copies of the same. Members present were Timothy Nelsen, Steve Lade, Jerad Sornson, Charles Ron Hauptman and Rick Freshman. The following motions were passed by majority vote: To set the levies for the taxing entities within Otoe County. To adopt Resolution 10-11-16-34 approving and ratifying the Interlocal Agreement for Law Enforcement Services between the City of Syracuse and Otoe County. To authorize the Chairman to sign and execute the Independent Contractor Agreement between Kelsey Wiest and Otoe County involving administrative support for the Otoe County Visitors Committee. To allow the County Treasurer to invest up to \$500,000 in Certificates of Deposit.
