

The Otoe County Board of Commissioners convened in regular session on Tuesday, May 14, 2019 at 8:30a.m. in the County Courtroom (108) of the Courthouse at Nebraska City; then convened as the Board of Equalization at 9:45a.m. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, James Parsons, Rick Freshman, Dean Speth and Jim Thurman. The following motions were passed by majority vote: to approve the purchase of two Dodge Durangos for the Sheriff Department from Larson Motors in the amount of \$52,162.00 which includes the trade-in allowances of \$3,000 for the Dodge Ram and \$2,000 for the Ford Expedition; to authorize the Chairman to sign a letter in support of LB86 and Amendment 1199; to purchase tubes and connecting bands from Metal Culverts; to approve and authorize the Chairman to sign Resolution 5-14-19-8 to amend the Utility Policy adopted in 2013; to approve tax list corrections as presented by the County Assessor; to agree with the Assessor's recommendation on the partial approvals and denials of real estate property tax and personal property tax on property owned by Kimmel Orchard & Vineyard Educational Foundation, Inc.
