

The Otoe County Board of Commissioners convened as the Board of Equalization at 8:25 a.m. on Tuesday, April 23, 2019 in the County Courtroom (108) of the Courthouse at Nebraska City; then convened in regular session at 8:48 a.m. Minutes of the previous meetings were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, James Parsons, Rick Freshman, Dean Speth, and Jim Thurman. The following motions were passed by majority vote: to approve tax list corrections as presented by the County Assessor; to approve the Assessor's recommendation of tax exemption for Parcel #004693500 for the City of Syracuse; to sign a deed of property owned by Otoe Co. to the Land Reutilization Commission; to approve the reappointment of members to the Otoe County Board of Adjustment; to approve the request of \$6,000 KENO funds for the purchase of a new bus to Blue Rivers Public Transportation; to accept the bid of \$1,605.00 from Arbor Auto Sales for a surplus pickup.
