

The Otoe County Board of Commissioners convened in regular session on Tuesday, June 25, 2019 at 8:30a.m. in the County Courtroom (108) of the Courthouse at Nebraska City. Minutes of the previous meetings were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, James Parsons, Rick Freshman, Dean Speth, and Jim Thurman.
