

The Otoe County Board of Commissioners convened as the Board of Equalization at 8:25 a.m. on Tuesday, September 10, 2019 in the Otoe County Courtroom (108) of the Courthouse in Nebraska City; then convened in regular session at 8:30 a.m. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, James Parsons, Rick Freshman, Dean Speth and Jim Thurman. The following motions were passed by majority vote: to approve board notices as presented by the County Assessor; to approve tax list corrections as presented by the County Assessor; to sign Resolution 9-10-19-17 that allows the County Board to increase restricted funds an extra 1%; to sign Resolution 9-10-19-18 to adopt the County Budget for Fiscal Year 2019-2020; to adopt Resolution 9-10-19-19 setting the 2019-2020 property tax request at \$8,010,603.63 resulting in a tax rate of \$.339172.
