

The Otoe County Board of Commissioners convened as the Board of Equalization at 8:25 a.m. on Tuesday, November 12, 2019 in the Otoe County Courtroom (108) of the Courthouse in Nebraska City; then convened in regular session at 8:30 a.m. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, James Parsons, Rick Freshman, Dean Speth and Jim Thurman. The following motions were passed by majority vote: to approve tax list corrections; to authorize and sign an interlocal agreement to provide personnel and services for Southeast Nebraska Adult Drug Court, to approve the vacation plat of TMM Subdivision, to change the payroll schedule, to approve and sign resolution 11-12-19-28 to study the vacation of roads located with the NE ¼ or Section 3, Township 8, Range 9; to authorize the Highway Superintendent to move forward with discussion of options with changing the classification of the road at the intersection of King & 10 S from minimum maintenance to local road.
