

The Otoe County Board of Equalization convened at 8:25 a.m. and then convened in regular session as the Board of Commissioners at 8:30 on Tuesday, July 28, 2020 in the Otoe County Courtroom (108) of the Courthouse in Nebraska City and by the online Zoom platform. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, Rick Freshman, James Parsons, Dean Speth. Commissioner Thurman was absent. The following motions were passed by majority vote: to approve homestead exemption waiver requests; to approve tax list corrections; to approve board notices; to approve the subdivision plat of R. Anderson subdivision plat located in the NW ¼ of the SW ¼ of S 9, T 7N, R 10E; to approve a conditional use permit for indoor/outdoor storage of RV, camper trailers, pickup trailers and vehicles located on Lot 5, Block 1, Evergreen Plaza 2<sup>nd</sup> Subdivision; to approve a memorandum of understanding for reimbursement of funds to support the Juvenile Diversion/Central Navigator; to approve Crime Commission Grant Award and special conditions to receive funds; to approve a cost study of paving County Rd C starting on the West boundary line of Otoe Co. and extending East approx. 1.88 miles to the currently paved portion of County C with Burr Oak Lodge reimbursing the County for the cost of the study.
