

The Otoe County Board of Commissioners at 8:30 a.m. on Tuesday, September 22, 2020 in the Otoe County Courtroom (108) of the Courthouse in Nebraska City and by the online Zoom platform. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, Rick Freshman, James Parsons, Dean Speth and Jim Thurman. The following motions were passed by majority vote: to approve the use of the Courthouse lawn for an evening prayer vigil on Sept. 26, 2020; to approve and authorize the Chairman to sign Resolution 9-22-20-34 to authorize redemption of 2014 and 2016 bonds at a future date to be determined by the authorized officer; to approve and authorize the Chairman to sign Resolution 9-22-20-35 to authorize the issuance of the refunding bonds in one or more series in interest to cost savings to the County; to approve and authorize the Chairman to sign Resolution 9-22-20-33 directing the Treasurer to issue tax sale certificates; to approve a conditional use permit for Frontier Co-op for a chemical and fertilizer distribution building for customer pickup, delivery, and custom application business locate 3176 K Rd, Syracuse, NE.
