

The Otoe County Board of Equalization convened at 8:25 a.m. and then convened in regular session as the Board of Commissioners at 8:33 a.m. on Tuesday, October 13, 2020 in the Otoe County Courtroom (108) of the Courthouse in Nebraska City and by the online Zoom platform. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, Rick Freshman, James Parsons, Dean Speth and Jim Thurman.
