

The Otoe County Board of Equalization convened at 8:25 a.m. and then convened in regular session as the Board of Commissioners at 8:30 a.m. on Tuesday, December 8, 2020 in the Otoe County Courtroom (108) of the Courthouse in Nebraska City and by the online Zoom platform. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, Rick Freshman, Dean Speth and Jim Thurman. The following motions were passed by majority vote: to approve tax list corrections; to approve four candidates for the Otoe County Extension Board; to approve amendment to the zoning regulations; to approve cancelling check #20110392; to approve the vacation of all of County Road 107 North of H Rd, right of way in the East ½ of S3, T8N, R9E of the 6th P.M. Otoe County, with the current fence line as the new property line; to approve keeping all of County Road 91/156, in the West ½ of the North East ¼ of S3, T8N,R9E of the 6th P.M. Otoe County open as county minimum maintenance road; to approve resolution 12-8-20-43 approving the year-end certification of the County Highway Superintendent.
