

The Otoe County Board of Commissioners convened at 8:30 a.m. on Tuesday, March 9, 2021 in the Otoe County Courtroom (108) of the Courthouse in Nebraska City and by the online Zoom platform. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, Rick Freshman, James Parsons, Jim Thurman, and Dan Crownover.
