

The Otoe County Board of Commissioners convened as the Board of Equalization at 8:25 a.m. on Tuesday, April 27, 2021 in the Otoe County Courtroom (108) of the Courthouse in Nebraska City; then convened in regular session at 8:45 a.m. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, Rick Freshman, James Parsons, Jim Thurman, and Dan Crownover. The following motions were passed by majority vote: to approve tax list corrections as presented by the Assessor; to approve a motor vehicle exemption application as presented; to approve the Assessor's recommendation on real and property tax exemption forms as presented; to approve a proclamation to proclaim May as Community Action Month; to approve and sign a contract with Vanguard, to approve a preliminary plat of Golden View Subdivision, a four lot subdivision containing 40 acres located in the NE ¼ of S22, T8N, R9E, Otoe County, NE; to approve a conditional use permit to Nebraska City Utilities for applying waste water sludge; to approve Keno funds application to NCTC.
