

The Otoe County Board of Commissioners convened at 9:00 a.m. on Tuesday, September 14, 2021 in the Otoe County Courtroom (108) of the Courthouse in Nebraska following the tax request and budget public hearings held at 8:30 a.m. and 8:45 a.m. respectfully. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, Rick Freshman, James Parsons, Jim Thurman, and Dan Crownover. The following motions were passed by majority vote: to adopt resolution 9-14-21-18 to approve an additional 1% increase of the 2021-2022 restricted funds; to adopt resolution 9-14-21-19 approving the FY21-22 budget; to adopt resolution 9-14-21-20 setting the property tax for FY21-22; to approve the annual KENO report; to approve authorizing the Co. Treasurer to strike personal property tax from the tax roll; to approve entering executive session to discuss Covid protocols and policies; to approve resuming the meeting in regular session; to approve authorizing the Highway Superintendent to advertise for bids for the purchase of a motor grader.
