

The Otoe County Board of Commissioners convened as the Board of Equalization at 8:25 a.m. on Tuesday, October 12, 2021, in the Otoe County Courtroom (108) of the Courthouse in Nebraska City; then convened in regular session at 8:30 a.m. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, Rick Freshman, James Parsons, Jim Thurman, and Dan Crownover. The following motions were passed by majority vote: to approve tax list corrections as presented by the Assessor; to adopt Resolution #10-12-21-24 to set levies for the tax entities with Otoe County; to adopt Resolution #5-25-21-11A to amend the vacation resolution; to adopt Resolution #10-12-21-25 to authorize call back pay to a minimum of 2 hours; to authorize the Chairman to sign a lease agreement with NCCCF for probation office space; to approve a KENO grant application submitted by Nebraska City Parks Department; to approve the annual road report; to adopt Resolution #10-12-21-26 for the annual road report certification; to award the bid to Metal Culverts for materials for Project C-66(629) Burr NW; to approve entering executive session to discuss County Attorney staffing and space/relocation; to approve resuming the meeting in regular session.
